Agenda/minutes

Use of an OO Shared Drive for Open Data Cube community (ODCC)

- ACTION: Alex to finalise and put on Loomio for vote (DONE)
- Data package size is in the tens of gigabytes not terabytes and there are potentially other options to host however Drive is the preferred place
- AL and EH stated that the risk is low and that no legal document was required.
- ACTION: Alex to confirm with ODCC via letter and to create appropriate access for ODCC once agreed

FOSS4G SotM Oceania 2024 updates

- Alex to update us on budget and progress
- Budget approved by the Board
- Venue and date locked in (Alex)
- Final quote received by C3 and it looks reasonable
- Aiming to get website up this month and to get our prospectus out
- Travel grants are ramping up early too (budget will determine who the grant could apply to)
- EH stated that determining grants by ethnicity is something that should not be approached
- OSGeo Oceania budget contribution:
 - How much is needed? 5-10,000? \$20,000 put aside last conference
 - Intent to allocate 10k to TGP (pending FY24/25 budget discussion and approval)
 - Planning to request USD5k from OSGeo (Dorothy will write it up)
 - Should be done in next financial year

NZ GST

- We collected NZ GST in 2023 and need to lodge & remit funds owing (we are overdue)
- NZ GST - Alex and Greg can confirm we have been collecting NZ GST and paying invoices with NZ GST; however, no GST paid to the New Zealand government
- Need to gain access to the government portal
- Potentially escalate by employing an NZ Tax accountant who could help the situation
- ACTION: Eli to get in contact with Greg for further information about what has occurred re NZ GST

Directors

- Discussion on Loomio vote (when is the quorum reached if someone doesn't vote)
 - [OSGeo Oceania constitution](#)
 - Clearer clarity on quorum: if people don't vote, quorum is not reached. We need 50% + 1 (5 votes)
 - Loomio for the final vote; emails for discussions
- Updates about Alan Cheung's situation
 - AC had requested leave from the board chair prior to his absence
 - This was granted as per the constitution
 - Alan was welcomed back by the current board chair
- Discussion about the constitution rule of 3 missed board meetings (item 82.3)
 - To be enacted with a degree of common sense. The constitution, item 82.3 is a clause allowing the board to disqualify a director - at the discretion of active board members (Renee)

MOU with Geospatial Council of Australia

- Alex: nothing to update. Tony Wheeler is drafting it and was going to take that to a GCA board meeting
- Actions for proposing same template to other organisations

Proposed joint webinar with GCA

- We were invited to participate in a webinar with GCA. John & Ewen met with them on 26 Feb.
- GCA runs webinars and we could be part of them, but it would be on their platform which is normally a fee based service.
- That could be an occasion to reach out to new audiences, and maybe put on youtube for everybody however it is not critical for the first items to be freely available
- ACTION: Ewen and John to involve the newly formed Comms group re webinar with GCA

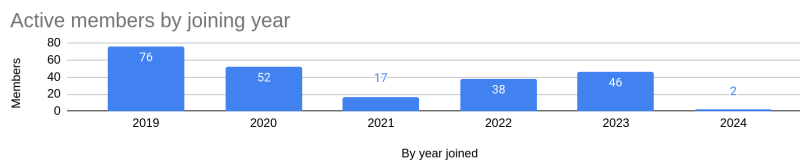
